# Membership conditions



- **membership is voluntary and open to legal entities registered in the Czech Republic, by a decision of the General Meeting of ICC Czech Republic**
- **The fee consists of two parts:**
  - payment of membership fee – 5.000,-\* or 15.000, - CZK (VAT exempt)
  - payment of service fee of 5.000,- \* or 20.000, - CZK or 30.000, - CZK (+ VAT) according to amount of discount demanded
  - \* - **Applied for small enterprise - A small enterprise, in the definition of Commission Recommendation 2003/361 / EC, means any entity engaged in an economic activity, irrespective of its legal form, which employs less than 50 employees and whose annual turnover or balance sheet total does not exceed EUR 10 million.**
